Appendix 2 - Minister's Report

I always thank my God for you because of his grace given you in Christ Jesus. For in him you have been enriched in every way—with all kinds of speech and with all knowledge—God thus confirming our testimony about Christ among you. Therefore you do not lack any spiritual gift as you eagerly wait for our Lord Jesus Christ to be revealed. He will also keep you firm to the end, so that you will be blameless on the day of our Lord Jesus Christ. God is faithful, who has called you into fellowship with his Son, Jesus Christ our Lord. (1 Corinthians 1:4-9)

This is my first report to the Board since I returned to work on April 1. In many respects, I feel like I 'hit the ground running', and felt the demands of ministry returning with full force. We held our Annual Meeting on Sunday April 13, and it is with great delight that we recognized Rev. Dave Steele and Rev. Arlyce Schiebot as Voluntary Associate Ministers. Rev. Dave and Rev. Arlyce come with vast experience and wisdom, and did amazing ministry while I was on Restorative Care. Their participation with us as a Community of Faith is a testament to the functioning and nurturing that you provide in Community.

Holy Week was also marked by the congregation with a lovely Good Friday worship service and a potluck supper. We had approximately 30 people attend (very approximate numbers because I confess that I didn't count), and the company and community was really lovely. Easter Sunday morning was a time of celebration that was enjoyed by approximately 50 people. On May 11, Mother's Day, we celebrated UCW Sunday, and had the gift of recognizing the Lifetime Memberships of 3 of our stalwart UCW members: Anne Dowie, Thelma Munro and Linda Hamon.

As well as my regular Bethel Activities, I have the requirement to be involved in Regional Activities. I am on the Ministry Support Leadership Team, a new Regional Team with the mandate to provide educational, social and personal support to other clergy in the Region. We hosted a Clergy Day away in Kemptville at the beginning of May, that included worship time, support time, a lecture by Rev. Jessie Zinck (Principal at Montreal Dio), and even some art! I led worship, taught a workshop on Progressive Muscle Relaxation, and enjoyed the comradery of my colleagues that I often feel are too far away for me to see. I have, on a regular basis, been drawn on to provide 1-1 support for some of my colleagues.

In addition to this Leadership team, I am the Pastoral Charge Supervisor for Grace United Church in Gananoque, and Addison United Church in Addison. Both of these congregations are at a significant crossroads in their ministry, and I am working with them and with the Regional staff ensure that they have the resources they need to move forward. This is time consuming, and often heartbreaking work, but their commitment to discerning God's plan through this is laudable.

I also continue work at the General Council level, and am on the Rural Ministries Network, and the Disability Theology and Justice Network. At this point, most of this work is information sharing.

I am busy, but I am also supported so much by all of you in this wondrous calling to ministry. For this, and for all of the care you demonstrated during my Restorative Care, and my return to work, I will always be grateful. It is my honour and privilege to continue to serve Bethel.



Our next meeting is scheduled for September 15th at 9:30 a.m. at the church hall. An email was sent out with an invitation to Bethel's employees to attend should they wish.




